Handbook



Netball Scotland's new Club Accreditation Scheme, THE THISTLE MARK has been created to support and empower our clubs to strive to be the best they can be.

THE KEY AIMS OF THE THISTLE MARK ARE:

- To ensure our clubs provide safe, welcoming and inclusive environments
- To support and empower our clubs to develop and improve club governance
- To support our clubs to have quality coaches, officials and volunteers
- To support our clubs to provide participation and/or competition opportunities for all

There are three levels of the Scheme open to clubs, **BRONZE**, **SILVER** and **GOLD**, follow the links to find out the criteria, rewards and application process for each respective level.

Applications will be accepted in line with the following deadlines over the course of the season:-

- 31st October
- 28th February
- 31st May

As well as on-going support from the Club & Competitions Manager and the Regional Development team, clubs can visit the **Club Tools** section on the Netball Scotland website to access a range of templates, guidelines and examples to assist you in developing your club.

Note: any club currently holding a valid Local Authority accreditation will automatically be awarded Netball Scotland's Bronze Level Accreditation, subject to providing evidence, and provided all club members are affiliated to Netball Scotland.

BRONZE LEVEL CRITERIA

GOVERNANCE

- Supply the name of and contact details for the main club contact or session facilitator. This should be correct & current for the season the club accreditation application is being submitted.
- Affiliate all club members to Netball Scotland.
- Demonstrate that the club is committed to enforcing equality under Netball Scotland's recommended guidelines.
- If the club has a junior section, demonstrate that all the individuals who work with any junior members have a certified PVG through that club.

PROFILE

 Have a social media and/or online club presence that is easily accessible for new and current members.

PERFORMANCE

• Demonstrate that the club encourages players of all levels of experience and ability to get involved in the game.

EMPOWERMENT

- Demonstrate that the club supports the development of club members with their personal development aims. This can range from players to coaches, umpires and volunteers.
- Demonstrate that the club has a session(s) that caters for specific target groups, e.g. Junior, Senior, BBN sessions, etc.

Bronze Level Accreditation Rewards

- A Netball Scotland accreditation certificate.
- Information on level of accreditation given when signposting new members and published on the Netball Scotland website.
- Exclusive use of the Netball Scotland Thistle Mark Logo for club marketing.
- Netball Scotland staff support to develop the club's ability to achieve higher accreditation levels.
- And much more

SILVER LEVEL CRITERIA

GOVERNANCE

- Supply the name of and contact details for the main club contact or session facilitator.
- Affiliate all club members to Netball Scotland.
- Have a club constitution or working club guidelines along with all necessary club policies, procedures and documents in place.
- Have a club committee in place, positions filled and hold regular meetings.
- Hold a club/treasurer's bank account with 2 x signatories.
- Have written and signed Role Descriptions for committee members to adhere to.
- Hold and record minutes of an Annual General Meeting.
- If the club has a junior section, demonstrate that all the individuals who work with any junior members have a certified PVG through that club.

PROFILE

- Have a social media and/or online club presence with regular communications with club members.
- Welcome all new members into the club equally.
- Have a club identity.

PERFORMANCE

- Demonstrate that the club encourages players of all levels of experience and ability to be involved in the game.
- Demonstrate your involvement with current competition opportunities.
- Encourage appropriate player development by nominating players for trials.

EMPOWERMENT

- Demonstrate that the club supports the development of club members with their personal development aims.
- Demonstrate that the club has a session(s) that caters for specific target groups.
- Encourage and support the development of club members gaining coaching and officiating awards/qualifications. *
- Demonstrate that the club recognises all club volunteers & members.
- Demonstrate that the club committee gives club members the opportunity to input into the running of the club.

- Supply the name and contact details for the main club contact or session facilitator.
- Affiliate all club members to Netball Scotland.
- Have a club constitution or working club guidelines along with all necessary club policies, procedures and documents in place.
- Have a club committee in place and positions filled and hold regular meetings.
- Hold a club/treasurer's bank account with 2 x signatories.
- Have written and signed Role Descriptions for committee members to adhere to.
- Hold an Annual General Meeting.
- If the club has a junior section, demonstrate that all the individuals who work with any junior members have a certified PVG through that club.
- Have a current club strategy or action plan.

- Have a social media and/or online club presence with regular communications with club members.
- Welcome all new members into the club equally.
- Have a club identity.
- Demonstrate that the club has developed community engagement.

PERFORMANCE


- Demonstrate that the club encourages players of all levels of experience and ability to be involved in the game.

- Encourage appropriate player development by nominating players for trials.

EMPOWERMENT

- Demonstrate that the club supports the development of club members with their personal development aims.
- Demonstrate that the club has a session(s) that caters for more than one specific target groups via a player pathway.
- Encourage and support the development of club members gaining coaching and officiating awards/qualifications. *
- Demonstrate that the club recognises all club volunteers & members.
- Demonstrate that the club committee gives club members the opportunity to input into the running of the club.
- Support and implement a coach development or mentoring programme within the club.
- Support or implement an officiating mentor programme.

APPLICATION SUBMISSIONS AND GRANTING AWARDS

The Thistle Mark application process differs slightly depending on each respective level your club is applying for, the details of which are summarised below.

ACCREDITATION LEVEL	APPLICATION PROCESS
BRONZE	Online Application Form
SILVER & GOLD	Online Application Request Form. This will notify Netball Scotland that you wish to submit an application for this level. An application pack will then be sent to your club – this pack is provided on a Netball Scotland USB which contains the following: - Application guidelines - Application form - Folders to provide application evidence Following completion of the application the USB (containing your application form and evidence) must be returned to Netball Scotland for submission and marking within the cycle deadline.

VALIDITY

The Thistle Mark Accreditation will be valid for 2 years from the point of being granted. Following this 2 year period clubs will be required to complete the accreditation process again, although at any point within this period they will be eliqible to apply for a higher level application.

BRONZE LEVEL SILVER LEVEL GOLD LEVEL

- Clubs are eligible to apply for any accreditation level at any point.
- There are 3 submission deadlines in each season and clubs must complete the appropriate application process prior to/on these dates in order to be considered for accreditation within that cycle.
- Submission deadlines are:
- 31st October
- 28th February
- 31st May
