1. Introduction:

Netball Scotland's Articles of Association gives provision for the establishment of Rules under Section 32, to provide effective operational support to the business.

By virtue of being a Member of Netball Scotland, Members agree to bind themselves to these Rules, cooperate to enforce these Rules and adhere to these Rules.

The following Terms and Conditions are adopted by Netball Scotland as Rules and are applicable to all affiliated Netball Scotland Members.

Members must ensure they are familiar with and understand these Terms and Conditions.

2. Membership Affiliation Period:

Netball Scotland offers different membership levels and different affiliation terms apply to each one, as set out below:

Level 1 Membership is free with an optional £8 contribution to Netball Scotland Level 1 Membership has no expiry date and does not require annual renewal.

Membership Levels 2, 3 & 4 are valid from the point of joining to 31 August each year. Unless otherwise stated, each membership affiliation term runs from 1 September to 31 August the following year. For example, a member joining on 1 September 2026 has a valid membership until 31 August 2027, or any part of the year thereof.

Memberships remain valid for the duration of the membership term unless ceased in accordance with the conditions set out below.

Membership is not valid unless paid in full.

If instalment payments are agreed as part of the membership, the first payment activates valid membership from that moment. Failure to complete all instalments revokes membership.

Membership is not transferable.

Membership shall cease upon death, resignation, expulsion, or failure to pay fees in full.

3. Membership Fees:

Level 1 Membership carries no membership fee. All other membership fees are set by Netball Scotland at its AGM and fixed for the duration of the Membership Affiliation Period, unless otherwise agreed.

Membership fees are non-refundable.

Membership fees are not available for any part thereof the Membership Affiliation Period, unless otherwise agreed.

4. Membership Benefits:

Netball Scotland reserves the right to change or amend the benefits of membership at any time and without prior notice.

Membership benefits are not accessible until membership fees are paid in full.

Level 1 Membership benefits are accessible immediately upon registration and remain accessible for the duration of the membership, which remains valid indefinitely unless ceased in accordance with the conditions set out in Section 2.

5. Insurance:

Insurance included in your membership benefits is only accessible if affiliation fees are paid in full.

If instalment payments are agreed upon for membership, the first payment activates valid insurance from that moment. Remaining instalments are due in full upon insurance claim acceptance.
